Terms and conditions

1. The competition promoter is Napier City Business Inc (NCBI) PO Box 526, Napier 4140.
2.
 - a. The cost to enter this competition is a minimum of one single purchase in a participating store.
 - b. To enter, the entry form must be completed in both sections, with the first section (Store Copy) of the entry form retained by the store. The second section (Customer Copy) is to be kept by the purchaser. The second section will need to be brought along on the day of the parade and placed in the entry box at the start of the parade. Entries cannot be accepted without the completed second section of the entry form.
